During 'Zero Hour', Professor Ranjan Chakrabarti, the Nominee of the Chairman of the West Bengal State Council of Higher Education, proposed that in terms of Para 26 of the Order passed by the Hon'ble Division Bench of Calcutta High Court date June 28, 2023 in WPA (P)/272/2023, read with sub-para (5) under Para 3 of the West Bengal State Universities (Terms and Conditions of Service of the Vice- Chancellor and the Manner and Procedure of the Official Communication) Rules, 2019 [WB Gazette Notification No.404-L/OM-143L/2019 dated 9th December, 2019], post-facto sanction of the State Government be taken for conduct of meeting in the Executive Council.

The present Vice-Chancellor is authorised to exercise the powers and perform the duties of the Vice-Chancellor by His Excellency, the Chancellor of the University. There are various important issues required to be dealt with by the Executive Council and regular meetings of the Executive Council are to be held.

Therefore, the Registrar of the University shall write to the Government of West Bengal, through the Principal Secretary, Department of Higher Education, to take note of the situation and to convey sanction for holding Executive Council Meetings regularly as and when necessary for smooth running of the University, including those, already, held.

Agenda Item No. 1

Confirmation of the proceeding of the meetings of the Executive Council held on 01.6.2023 & 18.07.2023.

The proceedings of the E.C held on 01.06.2023 & 18.07.2023 were confirmed and accepted

after incorporating the following changes.

At the time of confirmation of the proceedings of the E.C. meeting held on 01.6.2023 the following agenda were considered by the Members and confirmed after incorporating Changes/ corrections and/Modification with respect to the same :

- <u>The E.C. meeting dated 01.06.2023 Under Agenda Item No.43</u>: Under the ibid agenda, Dean, Students' Welfare was decided to be the Convenor of the Anti Ragging Committee instead of Security Officer, who would remain as member in the said committee.
- <u>The E.C. meeting dated 01.06.2023 Under Agenda Item No.1(b)</u>: Under the ibid agenda, Project Co-ordinator, E-Sodhganga was decided to be the Convenor of the committee constituted to frame and finalize the Ph.D. Regulations for the University in line with the UGC Regulations, 2022 instead of Joint Registrar, who would remain as member in the said committee.

Agenda Item No. 2

To report the action taken by the Hon'ble Vice-Chancellor on the decisions of the last E.C. meetings dated 01.06.2023 & 18.07.2023.

Resolutions

The Executive Council noted and accepted the actions taken by the Hon'ble Vice-Chancellor.

Agenda Item No.3

To discuss & determine the qualification requirements for the substantive post of Assistant Curator (Museum).

Resolutions

The Executive Council discussed about the qualification requirements for the substantive post of Assistant Curator (Museum) and decided the post to have the same qualification criteria as that of the post of Curator (circulated vide Go WB G.O. No. 141-Edn(U)/1U-91-08/11 dated 28.2.2011), except with respect to Experience and Age, as noted below :

Qualification Criteria

(i) Uniformly good academic record with a Master's Degree in History or in Ancient Indian History with minimum 55% marks or its equivalent grade in the point scale wherever a grading system is followed **and** a Post Graduate Degree or Diploma in Museology.

(ii) At least 4years' experience in an administrative position in a reputed museum.

(iii) <u>Age</u>: Not below 30 years (as on the date of employment notification), Relaxable in the case of exceptionally qualified candidates.

(iv) Scale of Pay : Pre-revised Pay Band of Rs.9000-28300 with Grade Pay (GP) : Rs.4600 [i.e. Revised as the Pay level 9 (i.e. Rs.37100-95500) as per Sixth Pay Commission. [Pay scale determined as per Go WB G.O. No.711(6) Edn(U) dated 24.4.1979)].

It was further resolved by the Executive Council that the criteria so decided would be forwarded to the Higher Education Department for necessary concurrences, since the said post was substantive in nature.

Agenda Item No.4

To consider the recommendations of the Boards of Studies of the various departments.

The Executive Council considered and approved the recommendations of the Boards of Studies of the various <u>departments under the Faculty of Fine Arts</u>, as mentioned below. Agenda Item No.5

To consider the application of Sri Dilip Das, Sr. Sweeper, Security Department of Rabindra Bharati University regarding his Voluntary Retirement from 1st. August 2023.

Resolutions

The Executive Council considered the prayer of Sri Dilip Das, Senior Sweeper, Security Department of this University for voluntary retirement in view of his deteriorating health issues and approved the same w.e.f. 31.08.2023 (A/N) in terms of GoWB Memo No. 85-Edn(U) dated 31.01.2000. Sri Das would be entitled for pension and other post-retirement benefits as per relevant rules.

Agenda Item No.6

To note the application of Professor Debalina Seth, Department of Bengali regarding rectification of Resolutions of E.C. meeting dated 08.02.2021 (under Agenda Item No.11) by way of amending the designation of the chairperson of Monitoring Committee formed in

connection with recruitment of non-teaching employees as Coordinator of IQAC (Chairperson) instead of Director, IQAC (Chairperson).

Resolutions

The Executive Council noted the application of Professor Debalina Seth, Department of Bengali regarding rectification of Resolutions of E.C. meeting dated 08.02.2021 (under Agenda Item No.11) and approved that the designation of the Chairperson, Monitoring Committee, formed in connection with recruitment of non-teaching employees be amended **as 'Coordinator, IQAC' (Chairperson)** instead of Director, IQAC (Chairperson). It may be mentioned here that Internal Quality Control Cell (IQAC) of the university was earlier composed of the Director, IQAC, as per UGC Guidelines for Establishment and Monitoring of the Internal Quality Assurance Cells (IQACs) in universities(2012-2017). But, as per the Guidelines for the Creation of the Internal Quality Assurance Cell (IQAC) [updated version as in April, 2022] issued by the National Assessment and Accreditation Council (NAAC), the same position has been renamed as Coordinator, IQAC.

Agenda Item No.7

To consider the recommendations of the meetings of the Faculty Council of Arts, Fine Arts & Visual Arts.

Resolutions

The Executive Council resolved to accept all recommendations made at the meeting of the Faculty Council of Fine Arts held on 28.07.2023. Since the meetings of the Faculty Councils of Arts and Visual Arts were yet to be completed, it was resolved to defer the decision relating to these Faculties to the next meeting of the Executive Council.

To discuss the opinion received from the Retainer Advocate in connection with the Resolutions of the Executive Council meeting dated 01.06.2023 under agenda item no.48 (F).

Agenda Item No.10

The Executive Council discussed about the qualifications and emoluments of the proposal approved vide Executive Council resolutions dated 01.06.2023 under Agenda No.31 and resolved to engage following employee on contractual basis for the Registrar's Department (two employees) and Vice-Chancellor's Secretariat (one employee) as per the qualification criteria, mentioned below : -

- (i) Name of the post : Office Assistant with knowledge of Computer and Stenography
- (ii) Number of posts : Three (03)
- (iii) Nature of employment : Full-time Contractual
- (iv) Educational Qualifications : (a) Minimum Graduate in any subject
 - (b) Knowledge of Computer;
 - (c) Stenography Speed : Minimum 100 WPM;
 - (d) Typing Speed : Minimum 40 WPM;
- (v) Age : Not more than 35 Years

- (vi) Period of Engagement : Initially for one year (may be re-engaged subsequently subject to the maximum age of 60 years depending on the requirement and satisfactory performance.
- (vii) Experience : Preference would be given to the candidates having office relevant prior experiences in administration at the Government/Quasi Government/ Private especially sectors. in **Educational Institutions.**
- (viii) Emoluments : Consolidated emoluments per month, as to be determined by the Finance Committee.

Resolutions

The Executive Council was intimated that Mr. Roshan Mondal, one of the candidates appeared in the interview for appointment to the substantive post of Assistant Professor in Environmental Studies, advertised vide Estt. /5271 /2016 dated 07.01.2016 & Estt. /6455 /2018 dated 27.09.2018, had filed a case with the Division Bench of Hon'ble High Court, Calcutta, (vide MAT No. 76/2023 CAN No.01/2023), challenging the order passed by the Single Bench. The matter came up for hearing on 27.7.2023 and the Division Bench had ordered the University to submit an affidavit in this regard by the next date of hearing listed on 10.8.2023. The Council was also apprised that the candidate selected for the said post, Md. Motakabber Ali, had already resigned and released from the University. As only

one candidate was selected for the said post and the panel prepared had a single name, the post of Assistant Professor in that Department is now lying vacant.

In view of the above, the chairman proposed to engage a new advocate to represent University for the said Court case. The Executive Council resolved to leave the matter on the discretion of the Chair. It was however directed to obtain necessary approval of the Finance Committee with respect to the fees and other legal charges of the said advocate.
