#### **Terms & Conditions:**

1. Bidden should have EPF, ESIC, GST Registration.
2. Price should be quoted per person per month excluding GST which will be paid extra as per Govt. norms.
3. Payment shall be made on a monthly basis against submission of GST invoices.
4. The contract will be valid for one year from the date of order.
5. The Contractor has to follow the minimum wage act of the State Government while paying to his staff.
6. The Contractor has to take all the medical liabilities of his manpower due to injury and health hazards arising from accidents while working on the campus during duty hours.
7. All statutory obligation like PF, ESI, etc. as applicable has to be borne by the Contractor.
8. For long absenteeism replacement of manpower to be provided by Contractor.
9. Each operator should sign the attendance register provided by the University.
10. Each operator should have a mobile phone.
11. The operator has to take additional jobs in the interest of the University whenever required.
12. Contractor should submit Aadhar card and Phone number of deployed person
13. Deployed person should have knowledge of operations of valves, pumps, water main etc.
14. Deployed person should check level of water in UG and overhead tanks and do necessary work to maintain normal water supply.
15. Contractor will be paid strictly as per quoted rate.
16. Time is the essence of contract. The contractor must have the potential to carry out emergency nature of job by engaging more manpower and resources at the time of requirement. They must carry out the job within stipulated time frame as decided by the department.
17. In case of repair of pump, motor the contractor has to replace by an alternative one if there is no stand by unit in possession of the University. No extra charge will be paid for alternative unit supplied.
18. Deployed person should have minimum 3 years experience in a reputed concern with similar job.
19. University reserves the right to terminate the contractor if found fault in quality and workmanship in the work or if the contractor is found to be deliberately delaying the progress of work in the opinion of the University.
20. University reserves the right to add, delete, and modify the conditions of the contract as and when necessary.
